

Letter To My Liberal Friends

December 22, 2015

My Dear Friends,

I felt hugely important to share this topic with you. The transcript of the Congress Investigative Committee on Benghazi consists numerous black and white, undisputable, "not matter of opinion, political affiliation, race or religion" information. The list below shows emails, statements and official State Department transcripts of Hillary Clinton's statements to various people within her circle, as well as to the American voting public. The two sets of statements represent 180° from each other, so by objective, impartial definition, we must conclude: one set is a lie. To make it easy to follow, I colored the two sets with two different colors. Please read them, then I would like to make some comments.

9/11/12 --6:49 PM

Official Transcript of The Secretary's call to S-Libyan General National Congress President Mohamed Magariaf:

"There is a gun battle ongoing, which I understand Ansar as-Sharia [sic] is claiming responsibility for"

9/11/2012 --10:32 PM

Official statement by Hillary Clinton to the nation:

"Some have sought to justify this vicious behavior as a response to inflammatory material posted on the Internet...."

9/11/12 --11:12 PM

Email to: Diana Reynolds (a pseudonym for Chelsea)

"Two of our officers were killed in Benghazi by an Al Queda-like group."

9/12/12 --7:11 PM

Official Transcript of The Secretary's call with Egyptian PM Hisham Qandil

"We know that the attack in Libya had nothing to do with the film. It was a planned attack – not a protest Based on the information we saw today we believe that the group that claimed responsibility for this was affiliated with al Qaeda"

9/14/12

Hillary's statement at Andrews Air Force Base, receiving the caskets

"We've seen rage and violence directed at American embassies over an awful Internet video that we had nothing to do with,"

9/15/12

Hillary's statement to Tyron Woods' father Charles

"We will make sure that the person who made that film is arrested and prosecuted."

9/16/12

Hillary Clinton's UN Ambassador, Suzan Rice appeared on ABC, CBS, CNN, NBC, Fox

CBS

"Based on the best information we have to date, what our assessment is as of the present is in fact what began spontaneously in Benghazi as a reaction to what had transpired some

hours earlier in Cairo where, of course, as you know, there was a violent protest outside of our embassy sparked by this hateful video...

CNN

"Let's recall what has happened in the last several days. There was a hateful video that was disseminated on the Internet..."

NBC

"...our current assessment is that what happened in Benghazi was, in fact, initially a spontaneous reaction to what had just transpired hours before in Cairo -- almost a copycat of the demonstrations against our facility in Cairo, which were prompted, of course, by the video..."

Fox

"...That what happened initially was that it was a spontaneous reaction to what had just transpired in Cairo as a consequence of the video..."

ABC

"...In Cairo, as you know, a few hours earlier, there was a violent protest that was undertaken in reaction to this very offensive video that was disseminated..."

Analysis:

Before I make my conclusions let me analyze the text above:

- *Hillary Clinton **did know** the true nature of the attack at 6:49 PM*
- *It took her exactly 40 min. to make two statements which were the polar opposite of each other: at 10:32 PM, she lied to the public, then 40 minutes later (at 11:12PM), she sent an email to her daughter telling the truth*
- *The very next day, she reaffirmed her knowledge to the Egyptian Prime Minister*
- *Two days after that, she lied to the face of the grieving families at Andrews AB, and*
- *Sent her ambassador to lie on five national TV shows two days after that*

Friends, before I share my conclusion with you, I need you to think and understand: these information are as impartial and objective as the 2+2=4 equation; these information are not governed by political agenda or any personal objective; there are written emails and official transcripts, all with time stamp. There is Suzan Rice's arrogant face on TV lying to the nation.

Conclusion:

I am a conservative. But wrap Abe Lincoln, Mother Theresa, Ronald Reagan, Margaret Thatcher, and Bill Buckley into one person; if "that" person lied 1/10th of what Hillary lied (just in this case alone) to this nation, there would be no force on this planet making me to vote for him/her. Not because of anger; not because of disappointment; but because of my own spine and self-respect. That I am not going to vote for anyone who lied to me. All (not "most"; all) other conservative friends and acquaintances from all walks of life I know would do the same.

“...Here’s a comparison of statements Hillary Clinton or her campaign have made about her email practices while secretary of state and statements made by FBI Director James Comey:

* * * *

CLINTON: “I did not email any classified material to anyone on my email. There is no classified material. So I’m certainly well-aware of the classification requirements and did not send classified material.” (Hillary Clinton, press conference, 3/10/15)

COMEY: “110 emails in 52 email chains have been determined by the owning [government] agency to contain classified information at the time they were sent or received. ... Separate from those, about 2,000 additional emails were up-classified to make them confidential. Those emails had not been classified at the time that they were sent or received... [Some] chains involved Secretary Clinton both sending emails about [top-secret-level] matters and receiving emails from others about the same matters.”

CLINTON: “I take classified information seriously.” (Hillary Clinton, [CNN interview, 2/1/2016](#))

COMEY: “Although we did not find clear evidence that Secretary Clinton or her colleagues intended to violate laws governing the handling of the classified information, there is evidence that they were extremely careless in their handling of very sensitive, highly classified information.”

CLINTON: “Nothing I sent was marked classified or that I received was marked classified.” (Hillary Clinton, [Democratic Presidential Town Hall on Fox News, 3/7/2016](#))

COMEY: “It’s also important to say something about the marking of classified information. Only a very small number of the emails here containing classified information bore markings that indicated the presence of classified information. But even if information is not marked classified in an email, participants who know, or should know, that the subject matter is classified are still obligated to protect it.”

CLINTON: “I have directed that all my emails on Clintonemail.com in my custody that were or potentially were federal records be provided to the Department of State, and on information and belief, this has been done” (Hillary Clinton, sworn statement filed in U.S. District Court, 08/10/15)

COMNEY: “The FBI also discovered several thousand work-related emails that were not among the group of 30,000 emails returned by Secretary Clinton to State in 2014.”

CLINTON: Asked if she “wiped” the server, “What, like with a cloth or something? Well, no. I don’t know how it works digitally at all.” (Hillary Clinton, [press conference, 8/18/2015](#))

COMEY: Clinton’s lawyers “cleaned their devices in such a way as to preclude complete forensic recovery.”

CLINTON: “The Secretary’s office was located in a secure area. Classified information was viewed in hard copy by Clinton while in the office. While on travel, the State Department had rigorous protocols for her and traveling staff to receive and transmit information of all types,”

COMEY: “She also used her personal email extensively while outside of the United States, including sending and receiving work-related emails in the territory of sophisticated adversaries. Given that combination of factors, we assess it is possible that hostile actors gained access to Secretary Clinton’s personal email account.”
