January 6, 2021

I'm watching what's happening in DC... some thoughts came to mind.

Anarchy, violence, looting, breaking, burning must be condemned in all form. By anyone who did it. I personally (and this is one person only) would not care if "looting, burning, anarchy started --- police showed up, giving one chance to everybody to go home --- after which bullets started to fly --- after which body bags were brought in" scenario played out. I would be 100% comfortable with the scenario.

Standing on that platform:

 Since G. Floyds' murder on May 25 various but significant parts of Seattle 6/23, Portland 7/27, Chicago 7/20, Los Angeles 9/21, Minneapolis 5/29, Milwaukee 6/5, New York 7/25, Washington DC 6/5, Pennsylvania 6/1, Louisville 9/24, Santa Monica 5/31, Atlanta 5/30 were burned down, all stores, banks, etc. looted, rocks, Molotov cocktails thrown, fireworks shot at police, innocent people beaten up and cars were set on fire.

Violence not only looked like this across the nation, but the dates were only one in various cities I found proof on the internet to; anarchy, violence, wholesale looting, "CHAZ", etc. were going for weeks, in many cases months. Black Lives Matter (BLM) and Antifa thugs and gangsters were invading the private home neighborhood of various republican representatives such as Mitch McConnel, Josh Hawley and several others.



- The political establishment (incl. all republicans) have done nothing. Not a thing. There was no investigation on who is financing BLM (to the tune of \$2 Billion -that's "B" for "Billion"), who is organizing the chaos and looting, who the leaders are, what is Antifa's structure, who the leaders are, etc. Fox News' "liberal voice" Juan Williams spent the entire 8 months in 2020 excusing the anarchy and/or explaining it. Biden, the spinless dementia ridden boss of his Cosa Nostra family said nothing or expressed his mild displeasure from his bunker in Delaware. 90% of the politicians condemned the police, many cities largely defunded them.
- There were dozens of statues brought down, desecrated, dragged, burned, destroyed across the country. Not a single city leader had lifted a finger against the; many times they approved them. It apparently didn't look like anarchy to them.
- Came the presidential election after which this is what we know with 100% certainty: four states (Pennsylvania, Georgia, Michigan, Wisconsin) allowed voting in a way which was in some aspect diagonal opposite to their own Constitution. The common denominator of the four states' illegality was: various leaders (governor, secretary of state, election commission) either disregarded, rewrote or abrogated election laws and procedures that -by their respective Constitution- could only be done by the state's legislature. This is undisputed by either side. On the other hand, the US Supreme Court's main function to be the final arbitrator on issues that have federal and Constitutional consequence. The USSC is not dealing with "facts"; they look at the constitutionality of the case and how consequential the case for future implication before them. <u>That is their job</u>. Under this principle, what is more "federal", "Constitutional" and "Consequential" than four states are running completely illegal, anti-constitutional election? And the USSC -shamefully- chose not to take the case.

That brought us to January 6th.

Again, I cannot condemn the attack on the US Capitol in any stronger terms. I also condemn President Trump who didn't send everybody home in the morning. While socialist left wing thugs' method of discussion is burning and looting, the conservative side's mode of operandi must be "discussion by presented facts." The model of this shall be Sen. Pat Toomey's Jan. 6th speech on the floor against "setting up a Congress Commission to investigate election fraud" as Sen. Ted Cruz recommended. Sen. Toomey's point was: it is not in the Constitution. And he made it elegantly. And he was right. This is the way how conservatives argue.

With that, let me make a few observations:

- The entire political structure (which didn't lift a finger during looting/burning across the country, when St. John Episcopal church in Lafayette Park -less than 100 yards from the WH, at which time the President had to be taken into a security bunker- was set on fire by Antifa and BLM thugs) became very upset when their own building got invaded. Now, all of a sudden they noticed it.
- Biden, this helpless, sorry but corrupt moron called the people in and around the Capitol "committing insurrection" and said he "never seen such anarchy." He didn't mention where he was between May and December of 2020 while half of the country was set on fire by his compadres.
- The entire American media (Fox News, N.Y. Post, Federalist and very few others as an exception) was purposely lying about the socialist, ultra-left anarchy going on for months, calling most of them a "peaceful demonstration."
- City leaders such as Portland, Seattle, Pennsylvania, New York and D.C. were covering up, in many cases assisting the chaos, looting and burning.
- Juan Williams at FOX News was very upset and condemned the "anarchy" (which in magnitude was about 1% of the anarchy we saw between May/December 2020; which Williams excused) and called it "anti-democratic"; what was he doing while St. John in Lafayette Park was burning, --he didn't say.
- The only arbitrators in the country that had the Constitutional responsibility, in fact liability to get involved in such a brazen constitutional violation what was committed by the four states is the US Supreme Court. The US Supreme Court neglected its responsibility; they might as well can dissolve. They lost their weight.

Looking at today, there are four takeaways:

- The country's conservative half has completely
 - lost trust in the American media
 - lost trust in the social media system
 - lost trust in the political structure and system
 - lost trust in all agencies responsible for "equal treatment under law"; FBI, NSA, and all others, including most district attorneys. In America, there is anything but "equal treatment under law" today
 - lost trust in the federal court system, especially in the US Supreme Court; this point is so strong that it can be argued from another side; the US Congress (as Legislative Branch by the Constitution) is elected by the people, for the people; the President of the United States (as the Executive Branch) does the same; one of the USSC's (as Judiciary Branch) job is to be the final arbitrator between the first two. There are approximately 74 million voters ("people"), most of them convinced this election was stolen. This highlights the USSC's historical blunder for not assisting to clear the issue up
- What happened on January 6th, is a direct responsibility of the US Supreme Court; there will always be people trying to cheat, to take election in a fraudulent way, to do something unbecoming. The US court system and the Supreme Court within are the final arbitrators in cases described above. The US Supreme Court failed its responsibility in 2020.
- Between 2017-2020 this country has been watching three year worth of mythology about "Russia!!", and "Ukraine!!", watching fake impeachment, watching slimeballs such as Swalwell, Schiff, Schumer, Pelosi and others' constant and blatant lies, watching the Speaker of the House tearing up the President's speech on national TV, reading/listening to the mainstream media's 24x7 lies, watching how the entire political structure works on undermining the President's work, watching the burning/looting of billions of dollars worth of private property, watching the desecration of dozens of historical statues ---but now we should be surprised that the allowed/encouraged anarchy is being extended to the Capitol Building. I just don't understand why. We either have "equal protection of the law" where a burger joint has equal value to its owner than the Capitol Building to any senator, --or we don't.
- On January 6th, 2021, on this historical day the American Democracy that the Founding Fathers set up for us was over and done with.
