

I am going to tell you an entirely, 100% unbelievable story; a story I probably wouldn't believe if I were outside of the US. But for the sake of this writing, let's assume what I am writing here is 100% correct; not only “correct” but 100% documented, using publicly available sources. “Publicly available sources” also mean recent testimonials before the US Senate Committee and stacks of emails that came to light within the last three months civil groups (under FOIA) sued the US government and they had to give up the emails. Not only 100% “documented”, but it has been the findings, publications, books, papers, and interviews of preeminent scientists. I reviewed a substantial amount of materials (approx.1,000 pages in total) and synthesized the findings in this short paper. The materials cited approximately three dozen scientists, each having credible standing in global science. A few of them are:

With that:

The story goes back to the early 1980s when the three main US characters during corona (Fauci, Birx, Redfield) worked in the same HIV research lab ran by a character, Dr. Robert Gallo. Gallo and his group (especially Fauci) stole the first isolated HIV virus from Pasteur Institute in Paris; Pasteur sued them and won the lawsuit. Later the scientists, who did the job, got the Nobel Prize, and Gallo got nothing. Gallo was a thief and a cheat (not only in the HIV case). In that setting, the issue during the HIV/AIDS “pandemic” was twofold. A large group of international and US scientists claimed that the HIV virus is not the only source of AIDS. Gallo's lab claimed it is. The difference was: IF AIDS' source is not only HIV, then there are several existing cures, pills, methodologies to prevent AIDS or handle it (patient doesn't die). At that time, Gallo was a “preeminent scientist” in virology in the US, so when he claimed HIV is “the” only source of AIDS, --that was it. No other opinion was entertained, and that entire line of thinking was shut down. An entire Congress-approved, government-ordered/financed industry was built on it. But two things came up from this saga: Fauci became the director of the National Institute of Allergy and Infectious Diseases (NIAID) in 1984, and the Playbook of “*We can achieve anything if we get the regulatory (government) side to create the necessary ambiance within the population, formulate necessary laws on one side, and use the medical industry in a way, that ‘it is serving’ the regulatory side’s decision*” was formulated. The “push the issue from two sides at the same time” was the key finding.

This “Playbook” was remarkably simple:

Step 1: Create a society-wide panic and make sure everyone believes: “the” only solution is a specific drug (medication, vaccine, whatever); a “specific” drug that can only be produced by a “specific” company or group of companies.

Convince everyone that no other solution is possible, no other remedy is available; all potential remedies currently existing on the market are useless and/or counterproductive.

Step 2: Team up with interested people, finance “scientific” articles and studies, use the media; force the regulatory side (regulators, government and congress) to accept Step 1., and provide laws, regulations for the public on one hand, tons of money for the “specific” group of companies for R&D and the created medication’s distribution on the other.

Step 3: Keep the public in a concerned, even panic mode, so they deeply appreciate the combination of Steps 1 & 2.

Step 4: As a result, make a ton of money.

(While reading the COVID story, keep these steps in mind and parallel them.)

As a result, the first HIV/AIDS drug AZT was approved in 1990.

Then came COVID.... Pres. Trump made one fatal mistake: appointing Fauci to head the task force. Fauci cost Trump the presidency and over 1.2 million lives in N. America and Europe.

From day 1, it was clear that this infection should be handled like any other (Hong Kong flu 1968-1971);

1. keep the elderly and vulnerable isolated
2. use proven, available methodologies and medications on patients who contracted infection
3. let everybody else live their lives

Based on Fauci’s orders, the U.S. and as an extension, the world did (and has been doing) the polar opposite:

1. We locked everybody down; we locked young people together with their elderly relatives (Italy was the prime example, but we in the US sent college kids home instead of keeping them in college dormitories. As a result, grandparents started to drop like flies). In several US states (N.Y. for one) nursing homes were ordered to take residents (who lived there, went to the hospital and came back) back; ---causing the statistic of “roughly 70% of all corona deaths happened in nursing homes.”

While we literally killed hundreds of thousands of elderly by not isolating them, destroyed families and businesses by locking down everything (incl. daycares, schools) the Swedish Public Health Agency reported at the end of 2020: Sweden kept daycares and schools completely open without any form of (mask mandate, etc.) restriction. Of Sweden’s 1.8 million children exactly zero child died and the infection ratio among teachers equaled to the whole population. Sweden also kept the society open and had better “numbers” than many countries in Europe, where everything was locked down.

2. It was proven in about two dozen countries that should the patient be treated with a list of available medications (among them: Hydroxychloroquine -HCQ-, Doxycycline, Fluvoxamine, Zinc, Vitamin D, Bromhexine, Azithromycin, Ivermectin, Zithromax, Quercetin) ***within the first five days*** the patient will avoid not only death, but hospital stays, even severe symptoms altogether. These studies (based on available results of thousands of patients) were created worldwide: Greece, Denmark, Canada, France, Saudi Arabia, Iran, India, Bangladesh, S. Africa, Russia, Brazil, ---everywhere. Not only were all of these studies and methodologies ignored, but all forms of media suppressed them. Patients were advised/ordered to stay at home if they felt sick and come to the hospital if and when their conditions worsened. ***This caused the patients to lose the all-important (in fact: lifesaving) first five days potential.*** Which was Fauci and his cohorts' sole objective (as per Playbook Step 1). This methodology exists to this day. Due to the denial of all existing and available drugs, as well as denial of natural immunity (which is far better and longer- lasting than vaccination), --the remedies the world is left with are “lockdown, keep distance, mask, and the hospital.” ***90% of the lockdowns, school closings, hospital treatments and other madness are the direct results of the non-existent ‘first five days’ treatment.”***

The list of data-based, historical, published examples underlying the importance of early treatment is a mile long; for example, in Yepes, Spain, corona infected two nursing homes; the mean age was 85 years, 48% of them over 80 years old. In 3 months, 100% of the residents were infected. ***None ended up in the hospital and, none died.*** All they used were antihistamines, steroids, antibiotics, vitamins and anti-inflammatories. Nobody was bothered by the fact that impoverished countries; (Niger, Congo, Ethiopia, and Mozambique), where HCQ and similar medications were the only ones available, reported far better COVID ratios than the U.S. and Europe. All studies, reports, scientific papers pointing to any direction other than “lockdown, mask, distance, hospital, and waiting for vaccination” were completely ignored; it was scientific/medical research gangsterism.

World-renowned epidemiologist scientists such as Drs. McCulloch, Kory, Cole, Brownstein and Rich opined: ***“Fauci’s suppression of early treatment and remedies based on existing medications is responsible for about 80% of all deaths attributed to COVID.”***

3. The world closed itself down causing approximately 150 times more damage with the “cure” of what the “illness” represented. The U.S. suicide hotline’s load had gone up by 2,300% between March-September of 2020. It is great fun to watch how Fauci and the members of the current US government have been trying to explain the unexplainable; that 18 months data shows: states (primarily TX, FL and several others) without any lockdown, and without 95% of the known restrictions having had approximately 1/4th of the hospitalization and death rates than those (N.Y., CA, NJ, IL, MI, OR) with total lockdowns and 100% of the restrictions. It is also a fact that ***all*** states with minimal restrictions are being run by republican administrations; and ***all*** of those with total restrictions, a much higher hospitalization and death rate are being run by democratic administrations.

It is easy to conclude that the US (and the world as an extension) has done the diagonal opposite of the standard pandemic protocol.

One can ask “why has this happened?” –It’s a great question.

The cast of characters are known to those who haven’t been busy hiding in fear, are not willing to use Facebook, Twitter and similar sewage canals as “data sources” and are willing to objectively read and research for real data. These are:

- Fauci&Co (Birx and Redfield)
- Bill Gates’ “Gates Foundation”
- Pharmaceutical companies
- WHO
- China
- Social media (primarily Facebook, Twitter, Snapchat), Google as search engine, US “national” TV media (primarily CNN, NBC, MSNBC, ABC) and printed media (this list is extremely long, but headed by -as far as serving the globe as “news and a data source” the NY Times).

Now remember the “Playbook” model from the HIV times because during COVID from day 1, all the elements of that scam will be identified here.

To understand the relationship between the actors, a few data points:

1. The current general director of the U.N.’s World Health Organization (WHO) was placed in his position by China.
2. The Fauci-ran NIAID financed (from US taxpayers’ money) bat-based corona virus research in Wuhan, China. Fauci -under oath- lied about this fact during several U.S. Senate hearings.
3. By far, the largest private donor to WHO is the Gates Foundation, accounting for close to 10% of its budget. In real numbers, the Gates Foundation is the second-largest donor of the WHO, after the U.S. government (U.S. government: \$893M, Gates Foundation: \$531M)
4. The Gates Foundation holds a major stake in Pfizer (since 2002), BioNTech (since 2019), CureVac (2015), Vir Biotechnology (2016); Vir started as a biotech company for AIDS and TB vaccine research; they moved over to the COVID vaccine field (...), Moderna (2016). The Gates foundation is the key contributor to Gavi, The Vaccine Alliance and CEPI, the Coalition for Epidemic Preparedness Innovations. They are the co-leader in WHO’s COVAX Facility and Advanced Market Commitment funds, Oxford University, etc. In this capacity, Gates pushed the University of Oxford to deliver its leading COVID-19 vaccine candidate to a partnership with AstraZeneca. They also have a financial interest in and are on the Board of significant drug makers, such as Merck’s Board.
Do these names sound familiar vis-à-vis COVID?
5. The global market size for COVID vaccine is approx. \$28B/year today and will grow to approx. \$42B/year by 2026. The global market size for COVID testing is estimated at \$11.4B/year.

These are the most significant relationships. There are several more such as:

- Gates Foundation financed studies to be published in major medical journals such as JAMA
- Gates Foundation was financing Neil Ferguson (Imperial College of London), supposed to be a “leading epidemiologist” to the tune of \$142M. Ferguson, with his phony “study” (predicting more than 500,000 deaths in the U.K. and more than 2.2 million in the U.S.) published, “got the ball rolling” in the “generate panic” phase.
- The Fauci-ran NIAID’s interest in all created intellectual properties
- A very long list of U.S. Congress members’ with direct ties (they are getting paid) to the Gates Foundation, and/or the pharmaceutical industry’s lobbyists.
- A vested interest of all political actors on the “democratic” side in preventing Donald Trump’s second four-year term
- Same vested interest of 95% of the American social media and other media channel

So, What Really Happened?

- The Fauci financed corona virus escaped from the Wuhan lab around August of 2019.
- China didn't disclose the problem until late December, locked down all domestic traffic in January 2020, but let international travel continue. One of the major destinations (because of guest workers) was Italy.
- Italy chose “the” worst model to stop the pandemic; locked people down at home in a country where multi-generation homes are the norm. It made the linear infection growth exponential.
- The China-installed, Gates funded WHO denied the “Virus from China” scenario on one hand and supported everything that was capable of causing more panic on the other. As an example, the WHO supported the “study” produced by Neil Ferguson.
- Once the virus showed up in the U.S., Fauci (a close friend of Bill Gates for years), Fauci's two cohorts (Birx and Redfield) and Bill Gates saw a once in a lifetime opportunity to get rich and famous (or in Gates' case: collect more money). It is still unclear who recommended Fauci & Co to President Trump (no one has the answer to this), but Fauci & Co became major players in the White House. These three agreed (this is documented) on day one: if any of the three were fired, all three would leave. As per Dr. Scott Atlas, one of the highest- ranked health policy experts in the world at Stanford (asked by the White House to participate on the team) said: he “was astonished by the fact that none of the three had ever brought a single piece of data to any of the meetings, how the three had zero knowledge of new scientific data from around the world (coming in daily) and how these three had never, not once argued, with each other.” The trio was there for one reason, and one reason only: to achieve the “regulatory component” of the two-sided pressure system prescribed by the Playbook.
- The HIV playbook was dusted off; push the regulatory side of the two-sided pressure system by “advising” the political side how to order lockdowns, school closures, business closures, and “everybody stay at home” orders. Use every possible tool (media, social media, medical journals, paid “experts” to write the necessary studies) to force the regulatory side of the pressure system. All these actions and advices were fully backed by the Bill Gates supported, China appointed WHO management, while the Gates Foundation was working in the background and waiting for the outcome.
- The sole objective was to get the public to believe:
 - Existing medications do not work, they are counterproductive, and there is no cure until vaccination.
 - Avoid all contact with everybody; otherwise, “your life is in danger” if you got closer to anyone than six feet. This is the only solution; otherwise, you can die. They knew this would generate panic, but that was “the” purpose.
 - Don't go to the hospital, unless you feel very sick; this talked everybody out of seeking medical attention and/or taking any medication within the all-important first five days.
- Setting up the regulatory side also included the complete discreditation of all existing drugs, methodologies, and treatments. JAMA, Lancet and other reputable journals got in on the act of publishing “research results” (most of them financed by the Gates Foundation). Since then, most such articles had to be recalled and corrected. Lancet (originally the most reputable journal of its kind in the world) lost all credibility in the process. But for the time being, the

scam worked; countries forbade the distribution of the existing medications (especially HCQ). They had gone as far as the Gates Foundation's people traveling to Africa, purchasing all available HCQ and burning them (to prevent people from using it). The sole objective was to channel everyone into “vaccination is the only God that can save us” thinking (“vaccines,” of course, produced by pharmaceutical firms with Gates Foundation as their major investor). The more people died in hospitals and the higher the panic level had gone, ---the more need for vaccination was generated.

- The media and social media's suffering from “Trump derangement syndrome” recognized: if the Trump government solves this problem, --Trump will get 80% of the votes in 2020. They could not allow that. Their shameful, bordering criminal activities got to a point when anyone (even a globally recognized Harvard scientist); who spoke for traditional medication, lockdowns, school closures, etc. was immediately and completely “de-platformed”; the person lost their Facebook, Twitter, etc. account. The American thought-fascism was born.
- In order to generate more panic, Fauci & Co. used completely phony statistical models that social and other media were happy to publish. To demonstrate Fauci's phony math, let's assume there are 5 million people infected with the flu, 1 million went to the doctor, 10,000 were hospitalized and 100 died. The produced statistic is “0.2% of the infected patients were hospitalized and 0.002% died.” Fauci and Birx used a different arithmetic: they started the math from the “1 million” point using it as “infected” baseline. With that, the ratios all of a sudden grow by 500%; hospitalization became 1% and death ratio 0.01% (good for business). These numbers are for demonstration only, because Dr. Bhattacharya estimated that infection rate was about fifty times higher than reported; it meant that hospitalization and fatality rates were off-base **by a factor of 50 (!)**. But, --for Fauci & Co. a higher ratio sounded and worked better; it added to the panic.

And the “panic strategy” worked; N.Y. City built a tent hospital in Central Park with 2,300 beds and converted a convention center into a make-shift hospital. The Central Park “hospital” never had more than 700 beds occupied, while the convention center hospital was empty. Yet, --it was portrayed that hospitals were way over capacity with Covid patients.

Of the 130,000 deaths in N.Y., 75% were over age 70, and 95% were over 50. Among the population 18 years and younger, who contracted Covid, the death rate was zero (0.00%). Of the first 6,570 death cases (fully investigated), 99.2% had underlying conditions.

In the meantime, under the heading of “we need hospital beds for Covid”; cancer screenings and surgeries, chemotherapies, stroke and heart attack care were delayed, thus creating a massive health and societal disaster.

Drs. Lipton, Atlas and Keeney wrote an article in May of 2020 (only four months into the pandemic): “Considering only the losses of life from missed health care and unemployment due solely to the lockdown policy; we conservatively estimate that the national lockdown is responsible for at least 700,000 lost years of life every month or about 1.5 million so far --- already surpassing the Covid-19 total.”

- As it was stated earlier, the last similar magnitude pandemic was the Hong Kong flu which happened between 1968-1971; in those years the U.S. landed Neil Armstrong on the Moon and organized the Woodstock Festival. The difference between the Hong Kong flu and Covid pandemic was the existence of social media and the 100% dishonesty of 95% of the American media (written or otherwise). While the American media was publishing packages of lies (to be repeated by global media), social media played a vital role. Up until the birth of social

media, life was better; we could keep insane people from talking to each other. As of today some 51% of the U.S. adult population between the ages of 20-40 regard Facebook and Twitter as their “primary data source.” It is not a surprise that the global panic had followed an exponential, almost logarithmic curve; entire (insane) populations using phony data (provided by Fauci & Co., backed by the Gates-supported WHO) kept elevating the panic level. This (plus players like Ferguson) greatly added to the pressure brought down on the governments (which were provided the same phony data from the same phony sources) to act. The way they acted was prescribed by Fauci & Co..

- As Dr. Atlas indicated Fauci & Co. prevented many crucial elements to see the light of day; all of them were factual, data-based and would have calmed the public. A few of those were:
 - Test should be done on the vulnerable not on healthy or asymptomatic people
 - Children do not transmit the virus; therefore, schools must be opened
 - As it was reported in *Clinical Infectious Diseases* “*an already dead corona virus is able to trigger a ‘positive PCR test result’; fewer than 3% (!) of ‘positives’ contain live contagious virus.*” But then again, if this information saw the light, where would the desired panic be?
- Once the “regulatory side” of the pressure system was established, not much was left to “succeed”; the government strongly advised against traditional medications, it threw (just in the HIV case) hundreds of billions into “vaccines” and “test kits.” This phase is in close parallel with the HIV playbook’s “the only solution is AZT” chapter.

Summarizing the above:

- Hundreds of epidemiologists around the world filed studies about their success using existing and immediately available medications
- Against the advice of those globally recognized epidemiologists, Fauci & Co. managed to advise the US government (followed by most countries in the world) to:
 - Avoid early treatment
 - Lock entire societies down
 - Accept patients in hospitals only when the level of their illness reached critical stage

In these efforts, Fauci & Co. had the full backing of the Gates Foundation and its money. By doing so, Fauci & Co. (with the active participation of the Gates Foundation) literally caused the death of millions of people worldwide.

Fauci & Co. then managed the “Only Way Out Is Testing Everybody and Vaccination” scam, financed by various governments (first and foremost: U.S.) around the world.

This topic is deep and wide with many connected areas clearly showing how much of a scam this was. A few of them are:

- Fauci’s categoric refusal of mask wearing all the way to January 28, 2020. There are 52 separate studies (all on NIH’s web site) stating an ordinary mask does not reduce viral infection rates. Fauci’s change of heart in the matter could be paralleled with his recognition of the potential financial gain brought by Covid fell into his lap. The birth of the “mask mandate” happened at the same time when Fauci & Co. started to vehemently deny the efficacy of existing, available and cheap medications to be taken in the first five days.
- Many scientists, among them, Dr. Scott Gotlib, former FDA commissioner stated: Fauci’s 6’ distance rule is arbitrary and has no scientific basis.
- Even WHO’s official pandemic protocols (formulated years earlier) recommended against “lockdowns.”

A very strong argument (more precisely: “conclusion”) can be made:

- Fauci & Co., with the backing of the Gates Foundation, denied society of “taking medication such as Hydroxychloroquine, Doxycycline, Fluvoxamine, Zinc, vitamin D, Bromhexine, Azithromycin, Ivermectin, Zithromax, Quercetin within the first five days”
-in order to allow Pfizer (with the Gates Foundation as one their major investors) to “invent” and start to market a medication (by December, 2021, 22 months into the “pandemic”) that prevents hospitalization **if taken within the first 5-6 days**.
- It is safe to say that

The world was prevented from using the **“Take available medication in the first five days and you will be OK treatment”** by Fauci & Co.,

and arrived to the:

“Take our new medication in the first five days and you will be OK treatment”
approved by Fauci & Co.

- Along the way the entire world economy crashed, close to 200,000,000 people suffered mental and health damage and 5.4 million people died; as the result of Fauci&CO and Bill Gates’ activities. Admittedly (because of the close ties between the hospital industry and governments) the real number died “of” Covid not “with” Covid was maybe 25% of the reported number; still, we are talking about 2-3 million total.
- After getting close to population control, containment and regulation last seen under the Nazis and communists in Australia their health minister Brad Hazzard finally admitted: *“A ‘reasonable proportion’ of COVID-19 hospitalizations in the Australian state of New South Wales are patients who were admitted to the hospital for other reasons but happened to test positive to routine COVID-19 virus in checks. Many of the people ‘hospitalized for COVID-19’ are just testing positive after being admitted for other illnesses and injuries, such as heart attacks, broken bones, mental health problems, and even giving birth.”* But hey! It has been good for business! The larger the panic, the better!
- Make no mistake about this: 80% of the 1-1.5 million people died for one reason and one reason only: because they (as per the “expert opinion” of the Gates Foundation backed Fauci&Co) were denied medication and care “within the first five days.”
- More accurately: Fauci&Co with Bill Gates’ backing caused the crash of the world economy and let 800,000-1.3 million people die to get to their roughly \$60B payday.

...and the band plays on...

Today in the US:

- No one is allowed to talk about “natural immunity” (which is far better and much longer lasting than what vaccines provide). There is no statistical data on that.
- No one is allowed to talk about data and studies with regards to traditional medication used in the first five days.
- As of 12/25/21, the newest “variant” (“Omicron”) has killed exactly three (3) patients in a country of 330,000,000. Yet states are considering lockdowns, school closures, etc.
- To this day the efficacy of Hydroxychloroquine and other medications are mentioned in the American media as “we don’t know their effectiveness because they were so politicized.” We (the rest of us) are here to believe: a pharmaceutical industry which could come up with a brand new vaccine in seven months cannot determine the efficacy of a medication that has been around for close to sixty years. How does the saying go? “I have the Brooklyn bridge for sale in case you are interested...”

- Today, the U.S. government (using Fauci’s “advice”) pushing for the “test everybody” idea; test before you fly, you go to hospital, concert, library, school, work place, ---anywhere. They cancel concerts, sports events, thousands of flights daily, cruises, they short staff hospitals, medical clinics and groceries; when someone “tests positive” with “Omicron.” “Omicron” with the danger level of a medium strength flu. Yet, there is still no “early treatment” available.
- As of 1/3/22 the US Government’s Customs Service in partnership with the FDA are inspecting all incoming packages and luggage to find Hydroxychloroquine and Ivermectin to confiscate them (“1938, here we come”)

Closing

Before we write the approx. 1,000 page worth of material as “conspiracy theory,” let’s quickly review the pieces of the puzzle. What is documented, available and factual:

- The WHO and Fauci were completely against “masks” in the first three months of the pandemic.
- The “no mask Fauci” became a “double mask Fauci” in three months; no one asked him, why?
- The WHO blindly supported the “no mask Fauci” and the “double mask Fauci.”
- The WHO lied about the virus’ origin, protecting the Chinese.
- 90% of epidemiology experts have been against the efficacy of “mask wearing and distance keeping” to this day.
- All available medications were denied, taken off the market.
- List of hospitals, nursing homes successfully used the same (denied) medications, wrote case studies about them. No one was interested in their citations and their findings.
- People were ordered not to go to the hospital and not to take medication until their condition was worsened (this in itself lost the all-important first five days).
- Nobody was interested why poor countries have far better “numbers” (using the early days treatment with available medication) than advanced countries.
- Nobody asked the question: in a supposedly dire situation like Covid was, why would anyone deny any kind of treatment, if that treatment has even a vague chance? And why would anyone deny “a” treatment that is being proven in dozens of case studies around the world?
- Nobody was interested in the Danish, Israeli and a list of other studies.
- Nobody was interested in why Sweden’s “numbers” were where they were, in spite of the fact that they kept everything open, and their society running.
- Doctors who spoke against masks, lockdowns or for existing medications were never seen again on TV (I saw several of them; once), and they were immediately silenced (deplatformed) on all social media.
- No one was interested in studies about the potential damage that lockdowns, etc. caused to society.
- The relationships between Fauci, the Gates Foundation, China and WHO.
- Fauci’s funding of the Wuhan lab in China.
- The Gates Foundation and Bill Gates’ investments in pharmaceutical companies.

Setting Drs. McCullogh, Kory, Cole, Brownstein and Rich’s opinion (***“Fauci’s suppression of early treatment and remedies based on existing medications is responsible for about 80% of all deaths attributed to COVID.”***) aside for a second and using pure logic, one -after some thinking and gathering factual information- can formulate several questions:

- Why the medical society discarded, disregarded, in fact completely suppressed successful research and experiment results based on various directions followed by fellow scientists around the world (achievements with available medications and treatments)?
- Why successful treatments were completely disregarded? Treatments such as Dr. Syed Haider in Austin, TX who treated more than 4,000 COVID-19-positive patients using Ivermectin, Fluvoxamine, Vitamin D, Vitamin C, Quercetin and Zinc? Of the more than 4,000 patients ***five were hospitalized and none died.***
- Why from day one the pharmaceutical community didn’t concentrate on “early treatment” to prevent hospitalization; instead of choosing the long-term “find vaccine” route? At least, why the pharmaceutical community didn’t concentrate on both researches? (to this, there is the answer: “Because if they put “early treatment” into focus, people would have started to ask the “Why don’t we use what we have?” question)
- It was established in the early days that a) children have as much immunity against Covid as they have against the flu, and b) they are not any more infectious as they are with flu. Why then we’ve been locking schools down?
- Why the medical society discarded, disregarded successful results of diverse ways handling the pandemic (Sweden v.s. Europe, Texas, Florida against N.Y., CA, MI, NJ, OR, WA, IL)?
- Why is it that to this day the official take on treatments with existing drugs (Hydroxychloroquine, Doxycycline, Fluvoxamine, Zinc, vitamin D, Bromhexine, Azithromycin, Ivermectin, Zithromax, Quercetin) is: “Well it has been so politicized we don’t have the answer” a connected question: How can medical research and experiment be “political?” ...and another one: “Who politicized it?”
- How can the WHO and a supposedly infectious disease expert (Fauci&Co) have an opinion with regards to a such a simple device as a “mask” on day one, and a diametrically opposite opinion 90 days later? Isn’t the “mask” simple enough and have been around long enough to know its characteristics? What happened in that 90 days?
- Why do we want to test “everybody” instead of patients who don’t feel well? Beside the above mentioned “3% accuracy of PCR”, testing everyone is one of the key elements of generating panic by increasing the “known infection ratio” which in itself useless. During any hard flu season (known death ratio in the US is between 50,000-65,000 every year) people are tested who feel ill. We don’t run around with test kits giving them to everybody. Dr. Paul Offit (Children’s Hospital of Philadelphia) said *“It’s winter, and this is a winter virus, and this Omicron is particularly contagious, so I think you were going to see an increase anyway. We test anybody who’s admitted to the hospital for whatever reason to see whether or not they have COVID, and we’re definitely seeing an increase in cases. However, **we’re really not seeing an increase in children who are hospitalized for COVID or in the intensive care unit for COVID.**”* ---Yet the “test everyone” concept is well and alive around the world.

As every complex-looking problem, this entire “pandemic” has a simple, easy to understand, bottom-line foundation ---once you found it. In the Covid case this was the ***“avoid patients taking existing medications in the first 5-6 days at all cost.”*** “That” was the name of the game. Everything else was designed to serve that one purpose. To achieve the objective, came:

- Medical journal articles
- Mask mandates
- Keeping distance
- Lockdowns

- Media and social media
- Suppressing everything and everyone that and who went outside of the official narrative (and objective)
- Test everybody
- WHO support of Fauci & Co.
- Pushing through the “vaccination is the only salvation” message

They had to succeed in denying early treatment to the entire global society, in order to cash in.

As a final statement, let me offer this for consideration: just think about a “research topic” (of any kind), where six research laboratories try to find a solution to the problem. Each of the six will have experiments and successful data as to what was experimented, tested and found; what works and what doesn’t. The labs cooperate, using each other’s data. All of a sudden, a deep pocket “financial entity” enters into the equation arbitrary naming one of the six laboratories as “the sole keeper of knowledge,” ordering the findings of the other five as useless and ordering everyone to silence the other five. It is not “research,” it is “research gangsterism.” Precisely what happened in the Covid saga.

I suggest to look at it this way: the entire system of criminal justice based on “presented evidence”; the prosecutor will take the case to court only if and when there is a credible, logical case history (presented by the investigators to the prosecutor). Every single “case history” is a puzzle. In a murder case who was where, when, who has alibi, how credible the alibi is, who had weapon or had access to it, etc. A “case history” is complete when all direct and/or circumstantial evidence have their rightful place in the “puzzle”, making it a credible case for the court. In the “Fauci&Co’s Criminal Case” there is no other way than what is presented here.
